Meetings

The full Governing Body meets at least once per term to perform its duties as outlined in the Governance Policy. It meets additionally each term for training sessions or as required.

Committees

There are three main Committees which meet at least termly to cover different aspects of the school operations. These are:

- Curriculum, SEND and Safeguarding
- Finance, Audit and Estate
- Parental & Community Liaison, Nursery and Fundraising (1).

A Performance Management & Governance Committee meets as required and at least once per year to review the performance of the Head and staff team and progress against the school's objectives.

There is also an adhoc Operating Committee which is called upon to support the Head and the management team as required with operation matters and considerations.
